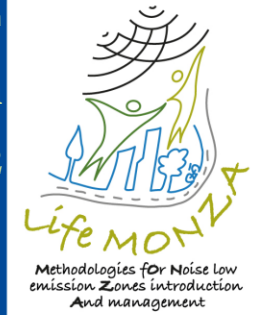

## 1. Summary

The Life MONZA project provides the promotion and dissemination of the results and knowledge acquired in the period following the end of the project itself.

This continuous process of communication and dissemination of the obtained results which starts from the commitment of the partners involved in this dissemination activity, represents an added value for the Life MONZA project and in this report the essential elements are provided.

The Plan for the After-Life phase of the project is essentially divided into dissemination activities involving scientific Associations, stakeholders and policy makers and Public Bodies.

Another kind of activities concerning the After-Life period are technical.

## 2. Dissemination activities

In this chapter are reported all the dissemination activities that the partners of the Life MONZA project are in planning to start and those ones that have already been started and which, in any case, will be completed in the period following the end of the project.

### 2.1 Scientific associations

For the 47<sup>th</sup> Congress of the Italian Acoustic Society, to be held in Matera on 23<sup>rd</sup>-25<sup>th</sup> September 2020, recently canceled, a structured session on the Life MONZA project had been organized. N.4 articles had already been sent in May 2020. Each participant was expected to deliver a USB flash drive containing the Proceedings of the final event of the LIFE MONZA project.

The aforementioned Congress has been postponed to May 2021 and on this occasion a specific session on the Life MONZA project will be available.

VIENROSE will participate to the Forum Acusticum 2020, which has been postponed from April 2020 to December 7-11, 2020, presenting an oral contribution relating to the "Life Monza Project: results of the activities carried out in the pilot area to reduce noise and to involve citizens in a new participatory approach ". The abstract has been formally approved.

VIENROSE will disseminate the electronic version of the final event documents to the European Acoustic Associations and Air Quality Associations through the EAA web portal. At this scope, a news will be published on the EAA website, together with a link to the section of the project website, dedicated to the collection of downloadable scientific contributions

### 2.2 Stakeholder e policy makers

About n.100 USB memory sticks will be distributed (VIENROSE) to participants of meetings of other EU co-funded projects, which are dealing with similar issues; in particular, the Networking activities were structured with the following projects:

- HORIZON 2020 ‘Noise and Emissions Monitoring and radical mitigation’ — ‘NEMO’ Project (Project in progress- Deadline 30/04/2023)
- LIFE18 E-VIA Project “Electric Vehicle noise control by Assessment and optimization of tyre/road interaction (Project in progress- Deadline 31/01/2023)
- LIFE15 NEREIDE “Project Noise Efficiently REDuced by recycled pavEments” (Deadline 31/03/2020).

VIENROSE will participate, at least for the three years following the conclusion of the project, in the EUROCITIES meetings where the results of the projects will be disseminated. The first one is expected in Turin in autumn 2020. In this context, the methodology and results of the top-down activities will be illustrated to stakeholders and policy makers, considering that the participants in the meetings of the Eurocities Working Group on noise are the responsible for the Environment Departments of the main European cities.

ISPRA will provide a *userID* and *password* to access in the protected area of the LIFE MONZA website for the representatives of Ministry of the Environment and Protection of the Territory and the Sea and to the Responsible of the Noise/Air Departments of ARPA (Italian Regional Agency for Environmental Protection), to allow them the direct access to monitoring reports and attachments.

An electronic version of the Layman Report (ISPRA) will be distributed to the ARPA mailing list within 3 months of the end of the projects

### 2.3 General public

Municipality of MONZA will guarantee the communication of the project through all the digital tools at its disposal. For the details of what can actually be done, the Municipality of Monza will implement a detailed action plan.

Municipality of MONZA will publish a news on the "Tua Monza" newsletter dedicated to the results of project. Hard copies of the newspaper will be distributed in the homes of the Monza's citizens and in the Civic Center Libertà, to be exhibited when the covid limitations are finished. The newspaper will be printed in 57,000 copies and will also be available on the website of the Municipality of Monza and on the official website of the Life MONZA project.

ISPRA will send to Legambiente (the main Association for the protection of the environment in Italy) both the Layman Report and the Guidelines in electronic version to be published on its website.

The website of the Life MONZA project (<http://www.lifemonza.eu>) will be kept updated by ISPRA and the materials produced, the news on the replicability of the project, as well as the communication on the developments of the activities foreseen in the After-Life will be available for public consultation for 5 years from the end of the project.

ISPRA will also provide support for specific questions from external users via email contact and FAQ section

### 3. Technical activities

MONZA - Activation of periodic maintenance service for smart sensors (from project, action E.2 "After-LIFE Plan", is expected the Municipality has allocated € 5,000 per year for the period 2020-2021-2022). The service should include:

- Replacement of panels, battery, microphones in case of deterioration
- Annual calibration check with mono-frequency calibrator (1 kHz - 94 dB)
- Any software and interface checks
- Any remote checks of any problems on the sensors, activating automatic checks on time history and frequency

UNIFI is available to provide remote technical assistance for any technological problems that the smart sensor system may present and for the control of the periodic recording of the indicators by the Municipality of MONZA in the next 3 years. The procedure for the periodic registration of summary indicators by the Municipality and the sending of these to UNIFI is being defined.
