As the European Green Capital of 2019, Oslo is taking up the battle against plastic pollution. The city has developed an ambitious *Action Plan to Reduce Plastic Pollution in the Oslo Fjord, 2019-2020* with the aim of becoming the first municipality in Norway that does not use unnecessary, single-use plastic. By the end of 2019, Oslo will phase out all use of unnecessary, single-use, plastic articles in the city's municipal bodies, and further ensure that when municipal property is rented out for events, the use of unnecessary, single-use plastic is reduced, and that other plastic is appropriately sorted and recycled. In the longer term, the city aims to phase out all use of unnecessary, single-use plastic articles throughout Oslo by the end of 2022.

This makes Oslo the perfect setting for this autumn's EUROCITIES Environment Forum focused on the impact of plastic waste on our cities. Throughout the three days, we'll work together to share inspiration and know-how on how to tackle the plastic waste problem and find concrete ways to better implement measures. Through interactive workshops we'll build cities' capacity to develop their own city strategy for plastic waste ensuring to develop strong relationships with business and harness citizens' power for an all-inclusive city strategy.

Olympic legacy: no more single use plastic in Paris for 2024

Caroline GARIN, Zero Waste expert, City of Paris

Paris is seizing the opportunity of the 2024 Olympic Games to accelerate the
ecological transition. By adopting a global zero waste strategy, the City of
Paris is committed to preventing and reducing all its plastic waste at source.
During this session, Paris will give a comprehensive view of its approach to
reach zero single use plastic by 2024.

CESBA MED: promoting energy efficiency of buildings at neighbourhood scale Enrico Gallo, Environmental Engineer, City of Turin

- Energy efficient measures and their implementation at neighbourhood level (i.e. district heating, PV installations, etc.) are showing clearly that a building scale approach is not optimal in reaching significant and costeffective improvements. Groups of buildings offer remarkable potentials for synergies. However, at neighbourhood scale, decision making processes and the design of the intervention are more complex. CESBA MED intends to find the most affordable and operational solutions for the development of energy efficiency plans at neighbourhood scale.
